The following is a summary of our progress on the subject projects for the month of February 2014.

### Project Management:

### General GEC

- Prepared & submitted CCRMA GEC Invoice for work performed on various Work Authorizations. Updated and submitted January 2013 GEC report.
- On February 13th, Richard Ridings, Eddie Garcia, Greg Garcia, John Becker and Jimmy Berry attended the Regular Meeting of the CCRMA Board of Directors.
- Assisted CCRMA Controller on activities involving reporting and documentation of invoicing, progress reports and other accounting/billing matters.

### West Rail Relocation International Coordination (Work Authorization No. 8):

This Work Authorization provides appropriate subconsultant(s) for staff coordination with the Mexican agencies to monitor and determine project schedules, permit requirements, funding technical agreements and design for the West Rail Relocation around Brownsville, Texas. The project plans will require approval by Secretaria de Comunicaciones y Transportes (SCT), Comisión Internacional de Limites Y Aguas (CILA) and Kansas City Southern Mexico (KCSM).

- Construction advances on the Mexican side:
  - Bridge, 100%
  - Patios and Roadway, 100%
- We are still waiting for the resources to be released for the six minimum construction items needed to initiate operations this will take place no later than February 15. The six construction items are:
  - I. Gamma Rays relocation.
  - II. Check point platforms.
  - III. The wall required by customs.
  - IV. Telecommunications tower.
  - V. Vehicular Pass
  - VI. Roads reconstruction.
- On Friday, February 7 at 10.30 a meeting took place with Customs and Border Protection, Cameron County and Customs General Direction to analyze the gamma Rays issue, agreements reached:

- First, the relocation on the Mexican side will take place, this process on the Mexican side will determine the date to initiate operations.
- On the American side equipment will also be relocated; therefore process details will be given at the meeting on March 7th.
- During this process CBP and SAT will be in ongoing communication.
- In regards to the delivery reception tables, we are waiting for Engineer Alfredo Briano Pérez, North Regional Coordination under Director from General Direction of Railroad and Multimodal Transport from SCT to send the invitation to the infrastructure and railroad operation tables. Engineer Javier Montero Casillas from Caxcan delivered the maps to be reviewed by Kansas City Southern México, it is possible that the first meeting will take place by the end of February.
- The 69th meeting of the Technical Group will be held on Friday March 7 at 11:30 am in the city of Brownsville, Texas.
- Union Pacific has provided the results of their final walkthrough. There are items that must be addressed prior to their acceptance of the project. The items include:
  - Install the end restraint at the crossing panel at bent 41 on the bridge
  - Recompact the subballast at the maintenance crossing at station 103+45
  - Complete the ballast to a 3:1 slope in accordance with the Union Pacific standard
  - Erosion has filled the culvert at Station 355+32. Resolve the erosion problem and clean out the culvert.
  - Grind field welds to provide a smooth crossing.
  - Complete the security fence on the bridge.

### South Padre Island Second Access Phase 3A & 3B (Work Authorization No. 17):

This Work Authorization provides engineering and environmental services associated with the development and advancement of the NEPA process for the proposed South Padre Island (SPI) 2nd Access Project in Cameron County, Texas. The proposed Project will provide an alternate route to the Queen Isabella Memorial Causeway: thus, enhancing local and regional mobility, and facilitating effective evacuation of the island in times of disaster, hurricanes, and other emergencies. This Work Authorization continues the environmental and corridor alternatives assessment tasks necessary to advance the project to a selection of a Recommended Preferred Alternative and ultimately to a Record of Decision (ROD). After the selection of a Preferred Alternative a supplement for schematic design and the FEIS will be required.

- Bathymetric survey was completed.

- Continued coordination with subconsultants on route and design studies for preparation of 60% submittal (i.e. typical sections, geometric design, preliminary cross sections, preliminary traffic control, 3D modeling, schematic plan preparation, preliminary construction cost estimate, hydrology, hydraulic studies, drainage design and preliminary bridge layouts).
- Submitted 30% complete schematic review package (i.e. schematic, DSR, engineering estimate and preliminary engineering report) to TxDOT for review.
- HNTB participated on the project 30% Plan Review for NEPA meeting with ENV and FHWA in Austin, TX on February 24, 2014.
- Revised master design schedule and submitted to subconsultants for review.
- Continued coordination with subconsultants on traffic forecasting and operational analysis.
- Continued coordination with subconsultants on geotechnical services.
- Continued preparation of FEIS and associated tasks.
- Coordinated with subconsultants on FEIS tasks.

### General Brant Road/FM 106 Extension (Work Authorization No. 26)

This work authorization provides professional services and deliverables associated with the preparation of a categorical exclusion (to be reviewed by the Federal Highway Administration in anticipation of possible federal funding) and the completion of the Section 404 permitting process (including the development of a conceptual mitigation plan) for the project.

### Olmito Switch Yard & Repair-In-Place Facility (Work Authorization No. 31)

This work authorization provides engineering services throughout the construction duration of the Olmito Switch Yard and Repair-In-Place (RIP) Facility by providing responses to the contractor's Requests for Information, Shop Drawing Review and As-Built construction plans.

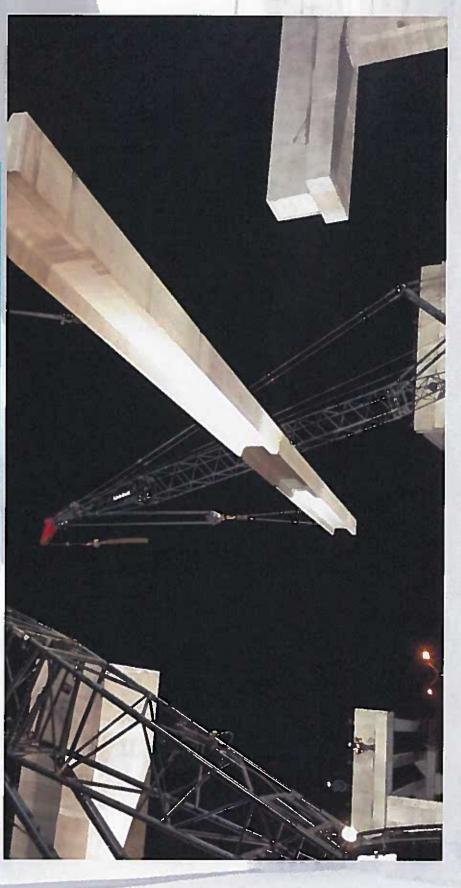

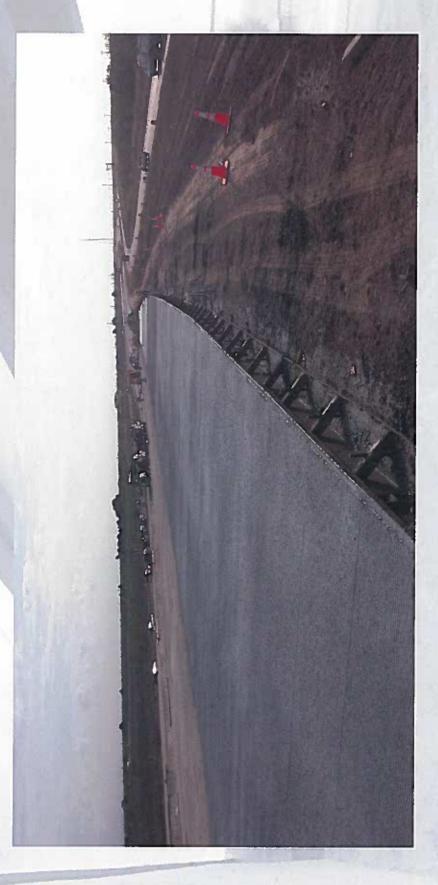

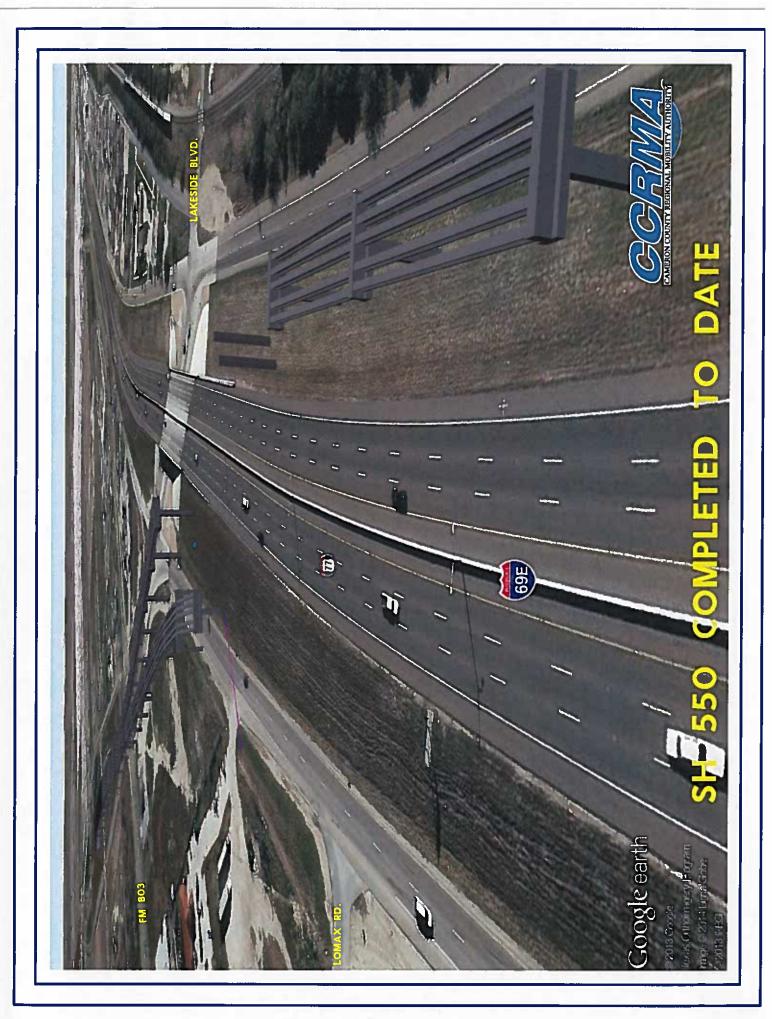

### **Vacation and Personal Time Policy**

January 2014

Page 1 of 2

### **POLICY**

It is the policy of the CCRMA to provide full-time regular employees time away from work for rest and relaxation, or for family/personal business, as staffing and customer needs permit.

### **Vacation and Personal Time Eligibility**

Full-time regular employees are eligible for vacation and personal time.

Vacation time will be available for use at the beginning of the calendar year, but will accrue each month. Personal time will be granted at the beginning of each calendar year,

Employees must successfully complete 90 days of employment before being eligible to take vacation or personal time off.

Requests for vacation are subject to the approval of the employee's Supervisor, and will be evaluated in light of business conditions, customer service needs and staffing schedules.

### **Annual Vacation Accrual**

Vacation time is accrued on a per-pay-period basis, according to following schedule unless an alternative agreement exists between an employee and the CCRMA. The accrual rate for annual leave, the maximum amount of accrued annual leave that an employee may carry over from one leave year (October 1 – September 30) to the next, and the maximum amount of annual leave payable upon separation from service are determined as shown in the following chart.

Completed Years of Service	Accrual Rate/ Pay Period	Annual Accrual	Maximum Carryover
0 - 4 years	3.08 hours	80 hours	40 hours
5 – 9 years	4.62 hours	120 hours	40 hours
10+ years	6.16 hours	160 hours	40 hours

In the event an employee is unable to take vacation prior to the end of the fiscal year due to Department needs, the employee is entitled a grace period of 3 months of the next fiscal year to take the vacation.

If the employee terminates employment with a negative vacation time balance, any used vacation time in excess of his/her earned accrual will be deducted from the employee's final paycheck.

The Executive Directors annual leave will be outlined in the Employment Contract.

### **Bereavement Leave**

January 2014

### **POLICY**

It is the policy of the CCRMA to provide employees paid time away from work in the event of the death of an immediate family member or domestic partner.

### **Definitions**

For purposes of this policy, definitions follow:

An "immediate family member" is defined as spouse, parent, person who legally served as
parent, sibling, grandparent, grandchild (whether natural relative, step-relative, or in-law
relative), child (whether natural child, adopted child, foster child or step-child), aunt, uncle,
or other relative who lives in the employee's home.

### **Eligibility**

A full-time regular employee experiencing the death of an immediate family member will be eligible to take paid bereavement leave. Leave for the death of a person other than an "immediate family member" (as defined herein) is at the discretion of the Executive Director.

### **Duration**

Paid bereavement leave will be granted for a maximum of three (3) workdays for an immediate family member. The days will be charged against sick leave/annual leave. If granted by the Supervisor, leave for the death of a person other than an immediate family member is limited to one day per calendar year, charged against sick leave/annual leave.

### Pay During Bereavement Leave

Pay during bereavement leave will be calculated at the employee's regular base rate of pay and time charged as stated above.

### **PROCEDURES**

The employee must notify the Supervisor as soon as possible when bereavement leave is required. The leave time is to be documented on the applicable time reporting system.

SUBJ: Intern-CCRMA Administration

The RMA has been working on developing an internship program with the UTB/UTRGV School of Business. Adrian recently met with the Chair of the Accounting and Management Information Systems, Hassanali Esphabodie, to establish some of the benefits and criteria of providing an internship to the students.

The Chair was in agreement with the duties outlined and mentioned that the service could qualify towards credit hours and if the student aims to become a CPA, then the service hours would count towards the minimum required under the supervision of Adrian.

We are proposing the internship with a \$10 hourly rate with a 10-15 hours a week schedule during the semester. The intern would not be eligible for any health or medical benefits but would have FICA and Federal withholding applied to their pay. From now to the end of the fiscal year the total cost will not exceed \$5,000.

I believe this is a small but beneficial way to get involved with our community and local University. I recommend board approval.

- 1. AUTHORIZATION TO PROCEED. The signing of this Agreement by the Client and AMEC will serve as written authorization for AMEC to proceed with the services called for in this Agreement.
- 2. ENTIRE AGREEMENT. - 11. RESPONSIBILITY. AMEC is not responsible for the completion or quality of work that is dependent upon or performed by the Client or third parties not under the direct control of AMEC, nor is AMEC responsible for their acts or omissions or for any damages resulting therefrom.
- 12. EXCLUSIVE USE. Services provided under this Agreement, including all reports, information or recommendations prepared or issued by AMEC, are for the exclusive use of the Client for the project specified. No other use is authorized under this Agreement. Client will not distribute or convey AMEC's reports or recommendations to any person or organization other than those identified in the project description without AMEC's written authorization.
- 13. FIELD REPRESENTATION. Unless otherwise expressly agreed in writing, AMEC shall not be responsible for the safety or direction of the means and methods at the Client's site of contractors or their employees or agents that are not hired by AMEC, and the presence of AMEC at the Client's site will not relieve the contractor of its responsibilities for performing the work in accordance with applicable regulations, or in accordance with project plans and specifications. If necessary, Client will advise any contractors that AMEC's services are so limited. The parties agree to negotiate adjustment of the lump sum amount if there has been, or is to be, a material change in the: (a) scope, complexity or character of the services or the project; (b) conditions under which the services are required to be performed; or (c) duration of the services, if a change in the schedule warrants such adjustment in accordance with the terms of the Agreement.

Part 3. Payment to the CONSULTANT for the services is not amended with this supplement.

Part 4. This Supplemental Work Authorization No. 13 to Work Authorization No. 17 shall become effective March 13, 2014 and makes no changes to the termination date of December 31, 2015.

**Part 5.** Except as amended herein, this Supplemental Work Authorization No. 13 to Work Authorization No. 17 does not waive the parties' responsibilities and obligations provided under the Agreement.
