SUPPLEMENTAL WORK AUTHORIZATION NO. 3 WORK AUTHORIZATION NO. 24 SH 550 Bidding and Contracting

This Supplemental Work Authorization No. 3 to Work Authorization No. 24 is made pursuant to the terms and conditions of the Base Contract, effective February 16, 2006, hereinafter identified as the "Agreement", entered into by and between Cameron County Regional Mobility Authority (the "AUTHORITY"), and HNTB Corporation (the "CONSULTANT").

Part 1. The CONSULTANT will provide the following engineering services:

The responsibilities of the CONSULTANT and the schedule are further detailed in Exhibits B, C and D.

Part 2. The Lump Sum amount payable for services performed under this Supplemental Work Authorization No. 3 is \$39,998.00 which increases the total amount payable from \$5,165,811.00 to \$5,205,809.00. A fee schedule used to establish the amount payable is attached hereto as Exhibit D. The CONSULTANT may alter the compensation distribution between individual phases, tasks or work assignments to be consistent with the services actually rendered, within the total lump sum amount.

The lump sum includes compensation for the services, subconsultant costs, if any, and appropriate factors for labor, overhead, profit and reimbursable expenses.

Although the CONSULTANT recognizes and accepts the ordinary risks and/or benefits of a lump sum fee structure, the parties agree to negotiate adjustment of the lump sum amount if there has been, or is to be, a material change in the: (a) scope, complexity or character of the services or the project; (b) conditions under which the services are required to be performed; or (c) duration of the services, if a change in the schedule warrants such adjustment in accordance with the terms of this Agreement.

- **Part 3.** This Supplemental Work Authorization No. 3 is effective as of May 14, 2012 and shall extend the termination date to September 30, 2012, unless extended by an additional Supplemental Work Authorization.
- **Part 4.** This Supplemental Work Authorization No. 3 does not waive the parties' responsibilities and obligations provided under the Agreement.

Part 5. This Supplemental Work Authorization No. 3 is hereby accepted and acknowledged below.
