Emergency Port of Entry Personnel and Infrastructure Funding Act of 2011 (Introduced in Senate - IS)

S 2767 IS

112th CONGRESS 1st Session

To provide additional resources and funding for construction and infrastructure improvements at United States land ports of entry, to open additional inspection lanes, to hire more inspectors, and to provide recruitment and retention incentives for United States Customs and Border Protection officers who serve on the Southern Border.

IN THE SENATE OF THE UNITED STATES

Mr. CORNYN introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

A BILL

To provide additional resources and funding for construction and infrastructure improvements at United States land ports of entry, to open additional inspection lanes, to hire more inspectors, and to provide recruitment and retention incentives for United States Customs and Border Protection officers who serve on the Southern Border.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the 'Emergency Port of Entry Personnel and Infrastructure Funding Act of 2011'.

SEC. 2. DEFINITIONS.

In this Act:

- (1) NORTHERN BORDER- The term 'Northern border' means the international border between the United States and Canada.
- (2) SOUTHERN BORDER- The term 'Southern border' means the international border between the United States and Mexico.

SEC. 3. CUSTOMS AND BORDER PROTECTION PERSONNEL.

- (a) Staff Enhancements-
 - (1) NEW PERSONNEL- In addition to positions authorized before the date of the enactment of this Act and any existing officer vacancies within United States Customs and Border Protection on such date, the Secretary of Homeland Security shall, subject to the availability of appropriations for such purpose, hire, train, and assign to duty, not later than September 30, 2016--
 - (A) 2,500 full-time Customs and Border Protection officers to serve on all inspection lanes (primary, secondary, incoming, and outgoing) and enforcement teams at United States land ports of entry on the Northern border;
 - (B) 2,500 full-time Customs and Border Protection officers to serve on all inspection lanes (primary, secondary, incoming, and outgoing) and enforcement teams at United States land ports of entry on the Southern border; and
 - (C) 350 full-time support staff for all United States ports of entry.
- (b) Waiver of FTE Limitation- The Secretary of Homeland Security may waive any limitation on the number of full-time equivalent personnel assigned to the Department of Homeland Security in order to fulfill the requirements under subsection (a).
- (c) Report to Congress-
 - (1) OUTBOUND INSPECTIONS- Not later than 90 days after the date of the enactment of this Act, the Secretary of Homeland Security shall submit a report containing the Department of Homeland Security's plans for ensuring the placement of sufficient United States Customs and Border Protection officers on outbound inspections and adequate outbound infrastructure at all Southern border land ports of entry to--
 - (A) the Committee on the Judiciary of the Senate;
 - (B) the Committee on the Judiciary of the House of Representatives;
 - (C) the Committee on Homeland Security and Governmental Affairs of the Senate; and
 - (D) the Committee on Homeland Security of the House of Representatives.
 - (2) AGRICULTURAL SPECIALISTS- Not later than 90 days after the date of the enactment of this Act, the Secretary of Homeland Security, in consultation with the Secretary of Agriculture, shall submit a report to the committees set forth in paragraph (1) that contains plans for ensuring the placement of sufficient agriculture specialists at all Southern border land ports of entry.

SEC. 4. SECURE COMMUNICATION; EQUIPMENT; AND GRANTS FOR BORDER PERSONNEL.

(a) Secure Communication- The Secretary of Homeland Security shall ensure that each United States Customs and Border Protection officer is equipped with a secure 2-way communication and satellite-enabled device, supported by system interoperability, that

allows such officers to communicate between ports of entry and inspection stations, and with other Federal, State, local, and tribal law enforcement entities.

(b) Border Area Security Initiative Grant Program- The Secretary of Homeland Security shall establish a program for awarding grants for the purchase of detection equipment at land ports of entry and mobile, hand-held, 2-way communication and biometric devices for State and local law enforcement officers serving on the Southern border.

SEC. 5. INFRASTRUCTURE IMPROVEMENTS AND EXPANSION OF LAND PORTS OF ENTRY

- (a) In General- In order to aid in the enforcement of Federal customs, immigration, and agriculture laws, the Customs and Border Protection Commissioner may--
 - (1) design, construct, and modify (or reimburse for construction costs) land ports of entry and other structures and facilities, including living quarters for officers, agents, and personnel;
 - (2) acquire, by purchase, donation, exchange or otherwise, land or any interest in land determined to be necessary to carry out the Commissioner's duties under this section; and
 - (3) construct additional ports of entry along the Southern border and the Northern border.

(b) Consultation-

- (1) LOCATIONS FOR NEW PORTS OF ENTRY- The Secretary of Homeland Security is encouraged to consult with the Secretary of the Interior, the Secretary of Agriculture, the Secretary of State, the International Boundary and Water Commission, the International Joint Commission, and appropriate representatives of States, local governments, Indian tribes, and property owners to--
 - (A) determine locations for new ports of entry; and
 - (B) minimize adverse impacts from such ports on the environment, historic and cultural resources, commerce, and quality of life for the communities and residents located near such ports.
- (2) SAVINGS PROVISION- Nothing in this subsection may be construed to-
 - (A) create any right or liability of the parties described in paragraph (1);
 - (B) affect the legality and validity of any determination under this Act by the Secretary; or
 - (C) affect any consultation requirement under any other law.

SEC. 6. AUTHORITY TO ACQUIRE LEASEHOLDS.

Notwithstanding any other provision of law, the Secretary of Homeland Security may acquire a leasehold interest in real property, and may construct or modify any facility on the leased property, if the Secretary determines that the acquisition of such interest, and such construction or modification, are necessary to facilitate the implementation of this Act.

SEC. 7. AUTHORIZATION OF APPROPRIATIONS.


There are authorized to be appropriated, to carry out this Act during the 6-year period beginning on October 1, 2011, \$6,000,000,000, of which--

(2) \$30,000,000 shall be used for Border Area Security Grants authorized under section 4(b).

SEC. 8. RESCISSION OF UNSPENT FEDERAL FUNDS TO OFFSET LOSS IN REVENUES.

- (a) In General- Notwithstanding any other provision of law, of all available unobligated funds, appropriated discretionary funds are hereby rescinded in such amounts as determined by the Director of the Office of Management and Budget such that the aggregate amount of such rescission equals the amount in outlays by reason of section 7.

 (b) Implementation- The Director of the Office of Management and Budget shall determine and identify--
 - (1) the appropriation accounts from which the rescission under subsection (a) shall apply; and
- (2) the amount of such rescission that shall be applied to each such account.
 (c) Report- Not later than 60 days after the date of the enactment of this Act, the Director of the Office of Management and Budget shall submit a report to Congress and the Secretary of the Treasury that describes the accounts and amounts determined and identified for rescission under subsection (b).
- (d) Exception- This section shall not apply to the unobligated funds of--
 - (1) the Department of Defense;
 - (2) the Department of Veterans Affairs
 - (3) the Department of Homeland Security

Statewide Transportation Improvement Program - Revisions

The STIP is a mechanism used by TxDOT and the Federal Highway Administration to fund projects for the next four years. The STIP includes all federally funded projects. The September 1 public meetings pertain specifically to FY 2011 August Quarterly STIP revisions that have gone through local project selection and public involvement processes. FY 2011 Carryovers

At the end of each fiscal year, unused State Highway Funds from TxDOT districts and applicable division-managed programs are reviewed for carryover into the next fiscal year. The public will be given an opportunity to review and comment on the carryover totals. The final approved amounts will be applied to the FY 2012 UTP allocations.

Category 5 and Category 7 Reconciliation

Category 5 funds Congestion Mitigation and Air Quality improvement projects in non-attainment areas throughout the state. Category 7 is funding for the eight Metropolitan Planning Organizations (MPO) serving populations greater than 200,000. The current reconciliation effort will allow the department and the affected MPOs to develop an agreed upon plan for the distribution of approximately \$200M in Category 5 and 7 funds. The effort includes public review and comment on the agreed upon plan.

Proposition 12 Distribution

Proposition 12 was approved by voters in 2007 for the issuance of \$5B in general obligation debt to be used to improve Texas highways. The first issuance of \$2B occurred in 2010. The second issuance, totaling \$3B, is scheduled to occur over the course of the upcoming biennium (2012-2013).

The specified funding amounts and categories are:

- \$1.4 billion to be distributed to the 25 TxDOT districts for rehabilitation and safety projects;
- 600 million for urban and metropolitan mobility projects to be selected by 25 MPOs in the state;
- \$500 million to replace or rehabilitate eight bridges, as specified in legislation;
- \$300 million to be sub-allocated to the four largest MPOs in the state Austin, Dallas/Fort Worth, Houston and San Antonio for the development of future mobility projects; and
- \$200 million for rural connectivity projects to be allocated by the Transportation Commission.

The Texas Transportation Commission is expected to approve these distributions at its September 2011 meeting. Districts and MPOs are working with local stakeholders to identify, prioritize and select projects during the months of August through October for consideration by the Commission.
