



Notice and Opportunity to Comment

FM 509 Extension

From FM 508/Combes-Rio Hondo Road to FM 1599

Cameron County, Texas

The Texas Department of Transportation (TxDOT) and Cameron County Regional Mobility Authority (CCRMA) are proposing to extend the existing Farm-to-Market Road (FM) 509 from FM 508 to FM 1599 in Cameron County, Texas. This notice is affording an opportunity to comment as part of the environmental review process for this project. If you are you are receiving this notice, our records indicate that you own property that would potentially be acquired (in part or in whole) for this project, or is adjacent to the project. This notice and opportunity to comment is also being provided to affected local governments and public officials.

The proposed project would consist of two 12-foot travel lanes, one lane in each direction, 10-foot outside shoulders with drainage swales, and 5-foot sidewalks on each side of the roadway. The proposed project would be constructed within a proposed roadway right-of-way 150 feet in width.

Although additional right of way would be required, no residential or non-residential structures are anticipated to be displaced at this time. Information concerning services and benefits available to affected property owners and information about the tentative schedule for right-of-way acquisition and construction can be obtained from the TxDOT Pharr District office by calling (956) 702-6101.

Any environmental documentation or studies, maps and drawings showing the project location and design, tentative construction schedules, and other information regarding the proposed project are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the CCRMA office, located at 3470 Carmen Avenue, Rancho Viejo, TX 78575. Project materials are also available online at https://ccrma.org/hearings-meetings-and-notice-schedules/ and www.txdot.gov, keyword: "FM 509 Extension."

What is being proposed?

The Cameron County Regional Mobility Authority (CCRMA) and the Texas Department of Transportation-Pharr District (TxDOT) are proposing to develop a roadway project that would construct a two-lane roadway with sidewalks within a 150-footwide right-of-way from Farm-to-Market Road (FM) 508 to FM 1599. This project, the FM 509 Extension, would be located northeast of Harlingen, Cameron County, Texas.

Why is this project needed?


The proposed project is needed to provide connectivity among local FM roadways and lengthen the overall FM 509 corridor, a south-north travel corridor, for improved mobility. The purpose of the proposed project is to improve regional connectivity, safety, and roadway capacity in Cameron County.

Preferred Alternative

An alternatives analysis was conducted, evaluating factors such as right-of-way (ROW) impacts, utility impacts, cost implications, and environmental constraints. After a thorough review, Alternative 3 was selected as the Preferred Alternative.


- Included in the Texas-Mexico Border Transportation Master Plan










FM 509 PROPOSED TYPICAL SECTIONS
