For the construction of the proposed LOS INDIOS LPOE – EXPORT DOCK RENOVATION.

Payment for the project will be made as defined in the specifications.

Sealed Bids for the above project will be received by Cameron County Regional Mobility Authority at 3461 Carmen Avenue, Rancho Viejo, Texas 78575 on or before 3:00 P.M. C.S.T., September 26, 2024. Bids will be opened at the same location at 3:01 P.M. C.S.T. (Cameron County Regional Mobility Authority time clock) on deadline due date.

The work under this Contract shall be Substantially Complete One Hundred and Twenty (120) working days after the initial notice to proceed (NTP). The Contractor will be allowed up to an additional ten (10) calendar days for Final Acceptance. The contract time includes the mobilization and materials procurement period. The complete list of estimated quantities is located in the bid tab. The principal items of work are as follows:

- Flexible Base
- Reinforced Concrete Pipe with Safety End Treatment
- Remove Concrete Rip Rap
- Remove Concrete Curb & Gutter (Sawcut)
- Remove Chain Link Fence
- Driveway 8" Concrete Pavement
- Concrete Sidewalk 4"
- Concrete Stairs with Handrails
- Gate Install Motorized
- Sliding Gate Rail Complete
- Building Renovation
- Temporary Portable Building
- Temporary Power Connection & Disconnect

Bids received after the above-mentioned date and time will not be considered and will be returned unopened. The Cameron County Regional Mobility Authority reserves the right to accept or reject all or any part of any bid, hold all bids for 120 days from the due date of receipt without actions, waive any technicalities or other informalities, require statements or evidence of bidder's qualifications, including financial statements, and award the bid which best serves the Cameron County Regional Mobility Authority. Award of bid shall be to the lowest responsible bidder as determined by the Board of Directors of the Cameron County Regional Mobility Authority in its sole and absolute discretion.
